

A new approach for Imagine 2050



Strategic alignment of research and monitoring for shared understanding

- Imagine 2050's value of accountability
- Creates opportunities for regional dialogues about trends, change, and progress
- Leverages new information and methods
- Fosters systems thinking about regional goals and policy
- Supports holistic, data-informed decisions and policy

2050 Amendment: two parts

Program narrative

- Describes conceptual model (outcomes-focused) and approach (programmatic)
- Commitments
- Guiding principles: Iterative, Adaptable, Meaningful
- Structure (regional indicators, regional measures, Met Council measures)

Measurement appendix

- Measurement “slates” of regional indicators, regional measures, and Met Council measures for
 - Each Imagine 2050 goal (5)
 - 2050 policy areas (land use, housing, parks and trails, water)
- Reflect current data availability to best of our abilities

Public comment report

- 15 comments received from 11 individuals and Washington County between October 23 and December 22, 2025
 - Commenters self-identified as residents (6), Met Council advisory committee members (2), local government staff (1), elected/appointed official (1), and advocacy/organization staff (1)

Key themes from public comments

- Support for measurement (generally) and several specific measures
- Size and scope of the program highlight the need for effective organization and communication
- Support for co-creating new data development projects with partners
- Some focus on specific measures (endorsing or questioning relevancy); unaddressed topics added to workplan for exploration
