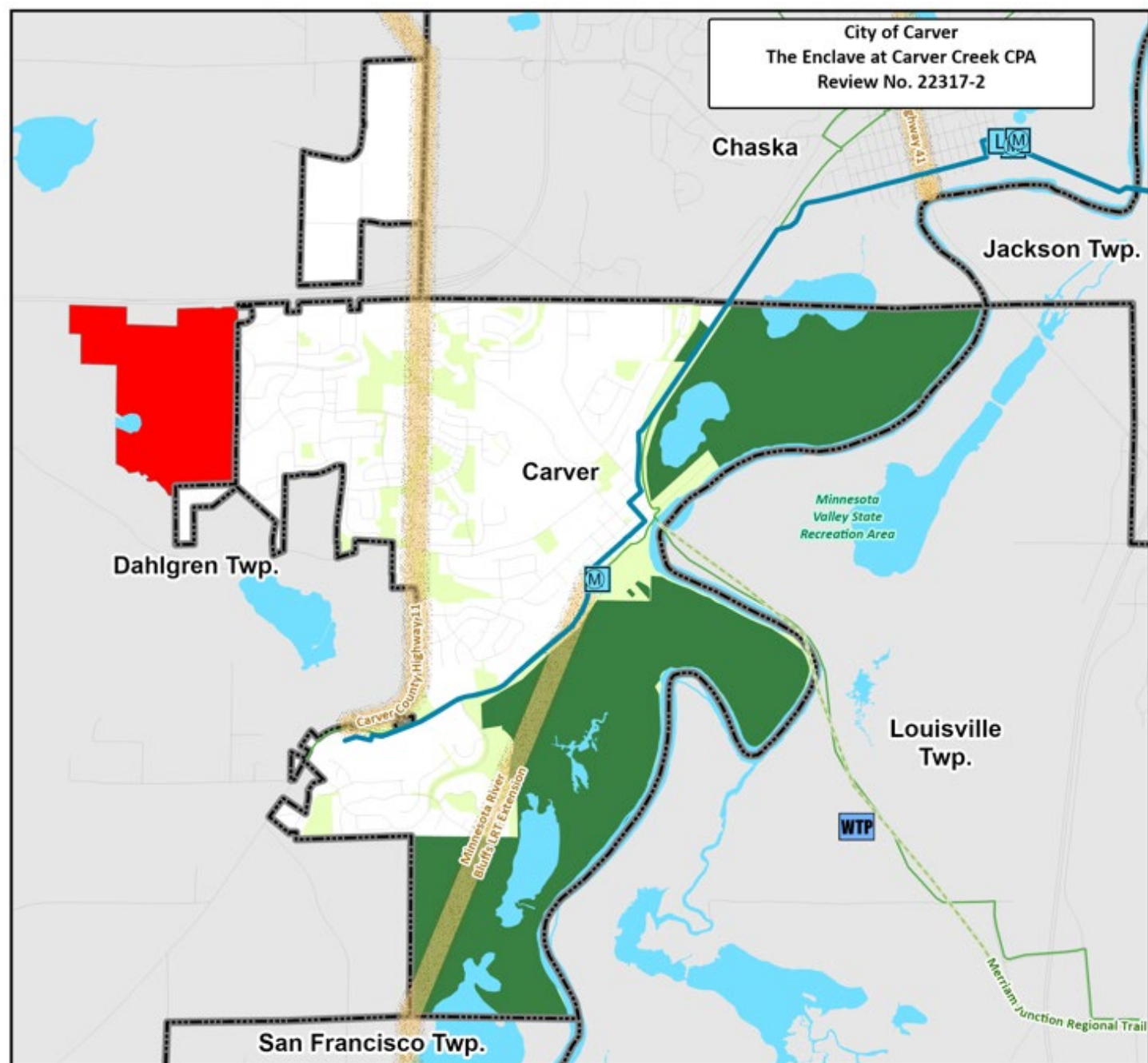

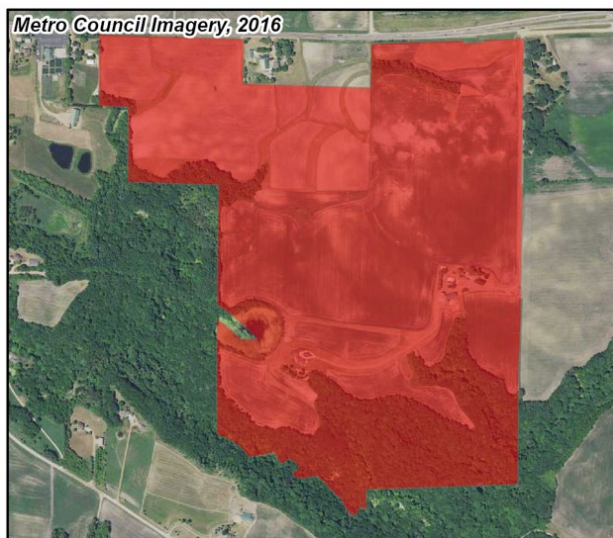

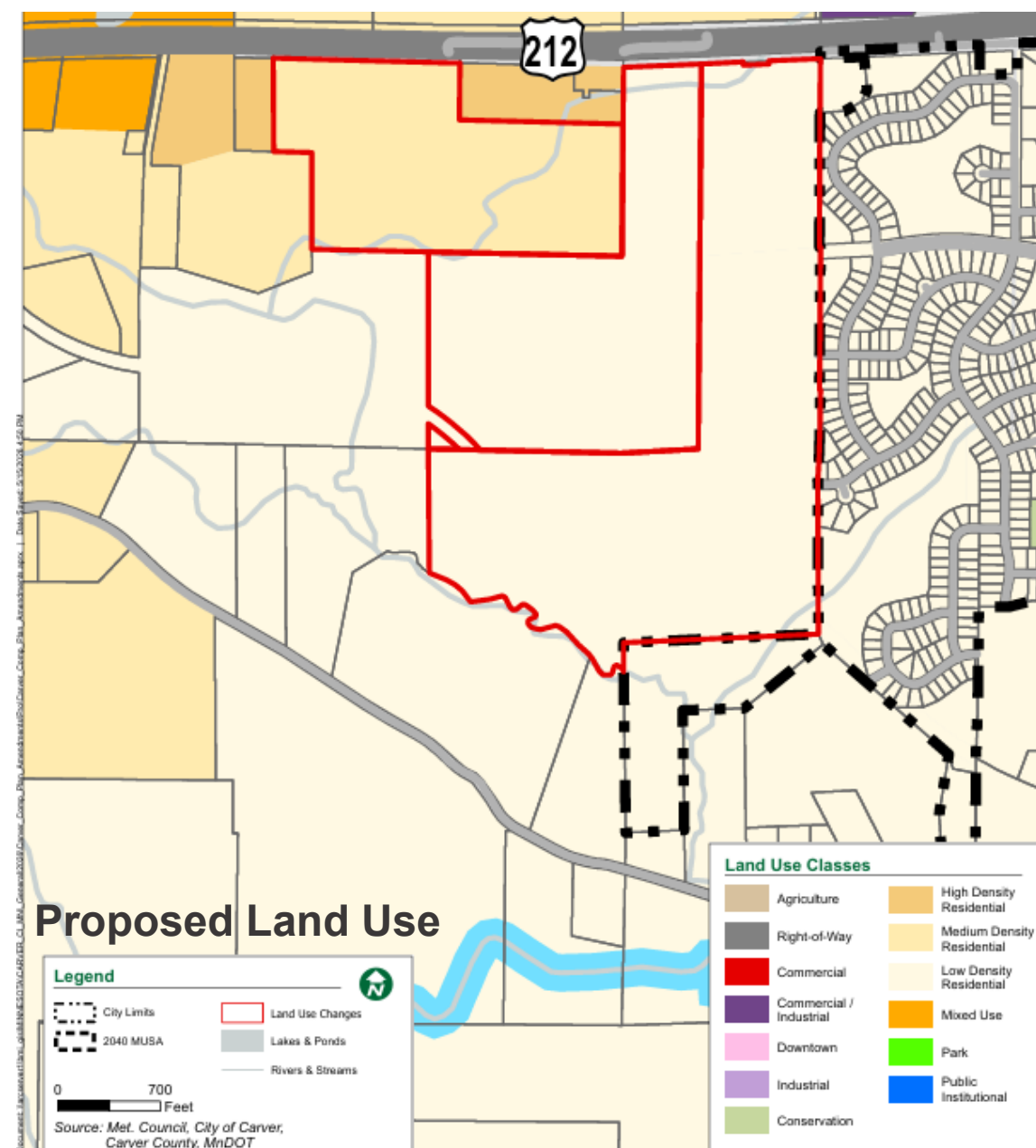
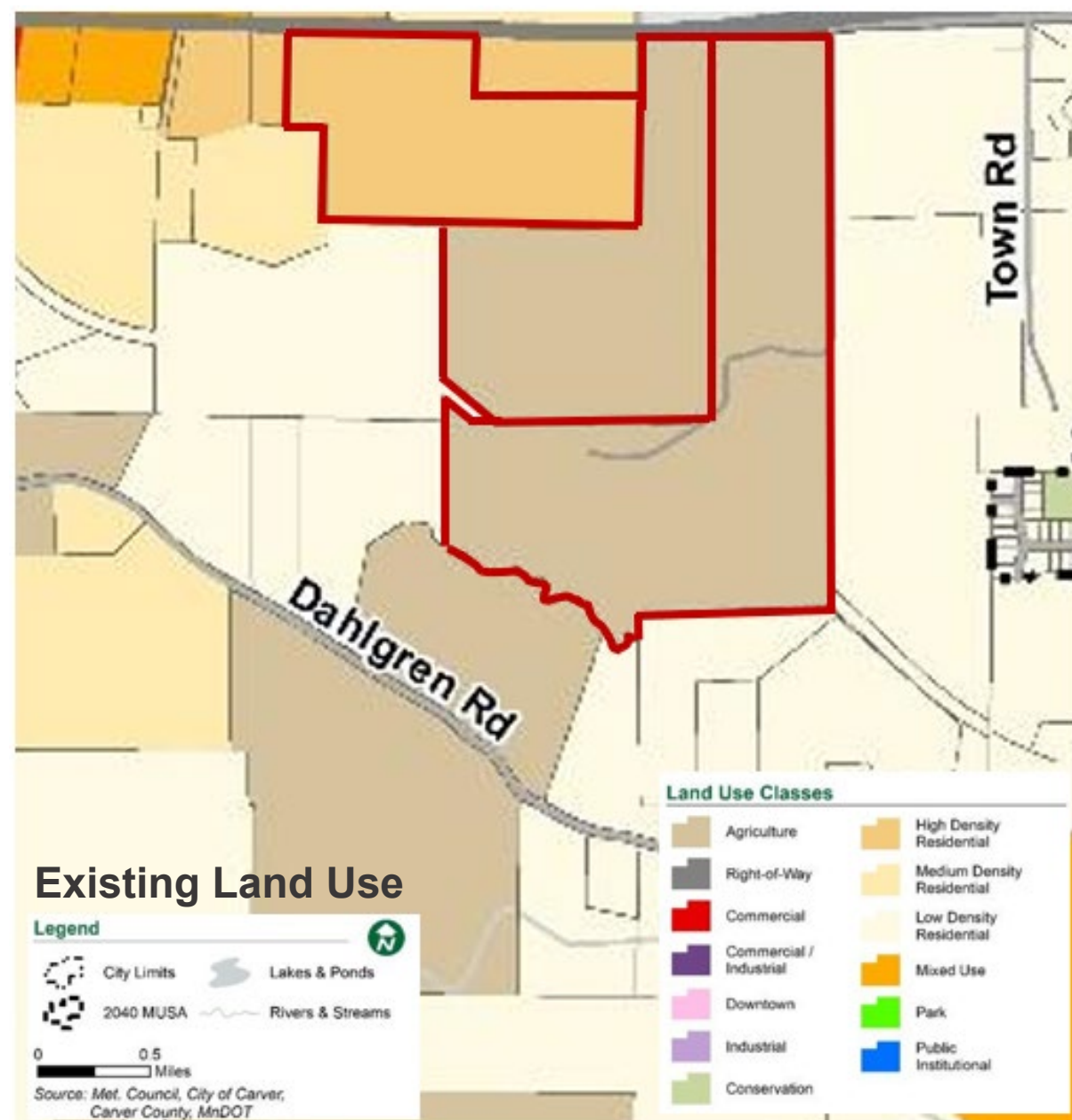


Amendment Details

- Reguides approximately 198 acres from Agriculture to Low Density Residential
- Reguides approximately 57 acres from High Density to Medium Density Residential
- Purpose is to facilitate a 508-unit development with a mix of attached (105) and detached single-family homes (403).

Findings



That the proposed amendment:

Proposed Action

1. Authorize the City of Carver to place its comprehensive plan amendment into effect.
2. Find that the amendment does not change the City's forecasts.
3. Advise the City to implement the advisory comments in the Review Record for Regional Parks, Transportation, Land Use, and Water Resources.
