


Information Item:
Update on Metro Area Water
Supply Plan Implementation



Subregional engagement is underway



Who participated?

Over 120 people attended the subregional kickoffs

- 6 meetings of the 7 subregions (E/NE combined)
- 47 cities and townships (land use, water resources, water supply, public works)
- 14 watershed management organizations
- 4 Soil and Water Conservation Districts
- 3 agencies
- 1 tribal government







What was shared?



Overarching themes for the region

- Affordable, accessible clean water is a concern
 - Supply, recreation, cultural
- Infrastructure needs
 - Maintenance, retrofitting for new pollutants, intermunicipal connections
- Desire for more education, lack of understanding of needs to deliver services
- Desire for collaboration
- Water supply, stormwater, wastewater systems are seen as most resilient to climate change impacts

Existing contracts to support work in 2026

These contracts support previously identified, specific work

- Contracts for engineering analysis extends through May 1, 2026
- Contract with University of Minnesota for irrigation research through December 31, 2027
- Contract with the University of Minnesota Technical Assistance Program (MnTAP) to continue supporting water efficiency audits and recommendations in businesses and facilities through December 31, 2027
- Contracts to support White Bear Lake Area Comprehensive Plan through June 30, 2027

New contracts to support priority work identified by partners and stakeholders


New contracts have been awarded to support the Met Council's Water Sustainability program, pending execution for total amount not to exceed \$4 million.

Metro Model

Regional Groundwater Flow Model for the Twin Cities Area



Groundwater is a vital resource that supports our drinking water, ecosystems, and local economies.

The Metro Model is a computer program that uses decades of data and cutting-edge science to simulate how groundwater moves, responds to climate and pumping, and interacts with surface water.

It's a key tool for sustainable water planning—helping agencies, planners, and communities make informed decisions today that protect water for tomorrow.
