

# Streamlined Annual PHA Plan (HCV Only PHAs)

## U.S. Department of Housing and Urban Development Office of Public and Indian Housing

**Purpose.** The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services. They also inform HUD, families served by the PHA, and members of the public of the PHA's mission, goals, and objectives for serving the needs of low-, very low-, and extremely low- income families.

**Applicability.** The Form HUD-50075-HCV is to be completed annually by **HCV-Only PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, High Performer PHA, Small PHA, or Qualified PHA do not need to submit this form. Where applicable, separate Annual PHA Plan forms are available for each of these types of PHAs.

### Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers (HCVs) and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments if administering both programs, SEMAP for PHAs that only administer tenant-based assistance and/or project-based assistance, or PHAS if only administering public housing.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS and SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or HCVs combined and is not PHAS or SEMAP troubled.

GOAL: Maintain/increase the availability of decent, safe and affordable housing and be responsible stewards of the region's finite resources.

- Maintained 98% utilization for the HCV program in most recent funding year.
- Updated 154 Council-owned housing units portfolio and maintained at 95% occupancy, in partnership with Kingwood Management.
- Presented and consulted with local communities to expand cooperative agreements in the Council-owned housing portfolio.
- Maintained utilization of 253 Mainstream Vouchers.
- Received 25 new Foster Youth to Independence Vouchers.
- Implemented a \$50 minimum rent

GOAL: Increase assisted housing choices for all residents across race, ethnicity and income through expansive owner recruitment and retention efforts.

- Offered individual consultations with owners and property management companies for HCV 101.
- Maintained a mitigation fund to support families who have financial barriers to retain owners.
- Completed a local research project on residential preferences to better understand housing gaps and opportunities in the region.
- Revised a digital media campaign to educate stakeholders on NSPIRE requirements and the PBV program
- Actively engaged the Minnesota Interagency Council on Homelessness to strategically address regional housing priorities for people experiencing homelessness.

GOAL: Encourage movement to areas in the region with less than 20% poverty and above average performing schools.

- Continued participation in the Community Choice Mobility Demonstration Program supporting more than 155 moves to opportunity areas as designated by the Demonstration.
- Selected and enrolled 36 families from the waiting list for enrollment into the Community Choice Demonstration Comprehensive Mobility Related Services (CMRS treatment group).
- Maintained the HRA's Outreach team of eight (8) staff facilitating stronger community partnerships, greater owner recruitment, increased resident engagement, and increased capacity to explore housing stability initiatives.

GOAL: Administer programs to encourage integrated settings to provide rental assistance for persons with disabilities. The Metro HRA administers the following programs assisting people living with disabilities:

- Non-Elderly Disabled program
- Mainstream program
- Emergency Housing Voucher program
- Continue housing stability interventions for existing Mainstream and EHV families

GOAL: Promote self-sufficiency and stabilize families.

- Continue to operate Project Based Vouchers in supportive housing projects.
- Continued partnerships with Anoka and Ramsey Counties for a Homework Starts with Home program to provide housing stability opportunities for students and their families experiencing homelessness.
- Continue research, informational interviews, and resident engagement to inform best practices for a future HCV Homeownership program and Family Self-Sufficiency program.
- Maintained an online resource for local homeownership and wealth building resources including but not limited to down payment assistance, credit and debt counseling, financial education, and culturally specific resources.
