Overview

- 473.1565 METROPOLITAN AREA WATER SUPPLY PLANNING ACTIVITIES; ADVISORY COMMITTEES.
- The Metropolitan Council must carry out planning activities addressing the water supply needs of the metropolitan area as defined in section <u>473.121</u>, <u>subdivision 2</u>. The planning activities must include, at a minimum:
 - development and periodic update of a metropolitan area master water supply plan, prepared in cooperation with and subject to the approval of the policy advisory committee established in this section, that:
 - emphasizes conservation, interjurisdictional cooperation, and long-term sustainability;



Overview

- Minnesota Session Law 2019 Ch. 2, Art. 2, Sec. 9:
 - \$375,000 the first year and \$375,000 the second year are for the water demand reduction grant program to encourage municipalities in the metropolitan area to implement measures to reduce water demand to ensure the reliability and protection of drinking water supplies
 - Effective through June 30, 2022
- Goal: improve municipal water use efficiency



Funding

- Grants to municipalities: \$2,000 to \$50,000
- Municipality provides 25% of total granted amount
- Example:

Metropolitan Council Grant Amount	\$15,000
Municipality Match	\$5,000
Municipality Grant/Rebate Program Total	\$20,000

 Applicants must be municipal water suppliers in the seven-county metro area



Eligibility

Selection criteria:

- Municipalities that are supplied 100% with groundwater
- Municipalities with identified water supply issues in Master Water Supply Plan Community Profiles or Local Water Supply Plans
- Municipalities' ratio of peak monthly water use to winter monthly water use
- Municipalities' average residential per capita water use
- The order in which applications are received and until grant funds are completely committed







Proposed Process

- All Metro Area Cities will be notified of funding July
 2019
- 10 weeks application period: July September
- A panel of Council staff and agency staff will evaluate and rank proposals and make a recommendation for funding to Environmental Services management:
 October- November
- Funding recommendation will be presented to the Environment Committee and then to the full Council for approval: December 2019

Proposed Action

 That the Metropolitan Council approves the process for 2020 - 2022 Water Efficiency Grants described in Attachment A of the business item and authorizes staff to advertise the availability of grant funding and solicit applications.
