The Metropolitan Council acknowledges that the land we currently call Minnesota and specifically the seven-county region is the ancestral homeland of the Dakota Oyate who are present and active contributors to our thriving region. As part of the Metropolitan Council's commitment to address the unresolved legacy of genocide, dispossession, and settler colonialism and the fact that government institutions, including the Metropolitan Council, benefitted economically, politically, and institutionally after the forceable removal of the Dakota Oyate, the Metropolitan Council is dedicated to instilling Land, Water, and People Commitments in regional policy. These commitments support the Dakota Oyate, the eleven federally recognized Tribes in Minnesota, Ho-Chunk Nation, and the American Indian Communities representing over 150 diverse Tribal Nations that call the seven-county region home.

State Disparity Study Results, Ashanti Payne, Assistant Director | Office of Equity and Equal Opportunity

Presentation Overview-

- Presentation of the State of Minnesota Disparity Study, conducted by Keen Independent Research LLC.
- Purpose: To analyze whether minority- and woman-owned businesses (MBEs/WBEs) are equitably utilized in Metropolitan Council contracts and subcontracts.
- The study also examined small businesses, veteran-owned, service-disabled veteran-owned, and disability-owned firms.
- Conducted jointly with **15 other public entities** across Minnesota (including cities, counties, MnDOT, MnSCU, and others).
- Timeframe analyzed: **July 2016 – June 2023**.
- Follows up on the **2017 joint study** led by the Minnesota Department of Administration.

I'd just like to say kudos for the job that you all have done, especially with the project bank accounts idea. As you know, that's been a point of contention because of slow pay issues. As a small business owner myself, I can understand the reluctance many small businesses feel about entering into financial partnerships on projects only to experience delayed payments and the negative impacts that come with that. So, I just want to say thank you for addressing that, and I hope the initiative moves forward successfully. I'm crossing my fingers that it's going to work.

Yes, it just came to mind. I'm sorry I didn't raise my hand earlier. I was looking at the materials and was wondering: what is Hennepin's Elevate program, and how does it differ from what the Met Council is doing? Is there something in their program that the Council hopes to model or adopt?

Payne, Ashanti – 28:39

Yes, Hennepin County's Elevate program is a small business support services initiative. I've had several in-depth conversations with the team that runs it. It's similar to some of the work we do we've actually incorporated a few of their ideas—but we don't want to duplicate services. Instead, we aim to leverage resources with partners like Hennepin County. Elevate, MnDOT, and the Department of Administration all offer various small business training and resources. One of our strategies is to continue funding our own support services program to provide similar assistance to small businesses interested in working with the Council.

Anita Urvina-Davis – 29:44

One other thing Hennepin County does a lot of community engagement and outreach through its programs. That may make a difference, especially when people have someone from the County consistently reaching out, providing information, resources, and assistance. That personal connection

really helps small businesses succeed. Maybe that's something the Council could also consider building more direct community engagement into its approach.

Yes, I just want to say I appreciate the depth of the executive summary and how comprehensive it is. It's a very complex topic with a lot of data, and seeing the real feedback and comments included was great.

We don't often see that level of authenticity it really stood out. One comment that especially struck me was, "I still feel like it's an old boys' club out here." That echoes what many people experience and helps guide our work. Another powerful comment was from a South American female business owner who said, "If it's a woman-owned business, people assume it's a passion project. They don't think I can run it like a business it's just me having fun." That really hit home.

Overall, I appreciate how the summary highlights recurring themes access to capital, bonding, insurance, prompt payment, information gaps, and bid-shopping in subcontracting. These are the same issues we see across all access points. I just want to thank you for putting together such an honest and detailed summary. It really helps us understand where we are and what needs work. I look forward to continuing the conversation on these major issues.

Anita Urvina-Davis – 36:47

I'm just full of information tonight excuse me but I had a discussion on Facebook with some seniors here in North Minneapolis. We were talking about Metro Transit and the safety concerns they've been experiencing on buses. They mentioned feeling unsafe and said they'd actually like to see more police officers or uniformed personnel present. I remember a few years ago when there was discussion about removing uniformed presence from buses and light rail, but now, the people I talked to—about seven seniors—said they'd feel safer if someone in uniform was around. They also mentioned wanting bus drivers to receive training on what to do when passengers feel threatened or unsafe. Another concern they raised was fare prices. As seniors, they'd like to see more discounted rates to encourage them to use the bus for errands like grocery shopping. So, between safety and fare affordability, those were the main issues they raised. I just wanted to share that here in case it's something this group might want to discuss further.

Yes, I'm hearing the same concerns. The recent loss of Sergeant Rodriguez really hit hard because programs like his are so important they connect people in need with housing and other supports. If those efforts decline, it can create ripple effects across the system. I ride public transportation myself, and while experienced riders know how to avoid certain issues, many people especially vulnerable ones don't. There's definitely a need for continued focus on safety and support programs. I completely agree with what Anita said, and I hope we can look at strengthening similar initiatives, especially for seniors and others who rely heavily on public transit.
